1. Small trading office, only 6 people in the 100m2 office
2. SGS audit date is only 29th of Jan, 2019
3. Company representative can not provide any company or product certification;
4. There two owners of this company: 李爱朋 (Randy LI) and 张玉琢 (Yuzhuo ZHANG, which is Randy's partner)
5. They mainly supply the domestic market before, and they started the overseas market last year in 2018-12 when they registered this company.
6. Randy LI is in charge overseas market and his partner who is in charge of domestic market holds shares of the factory;
7. They accept third-party inspections at the factory, and samples pick-up from the mass production for laboratory chemical testing;
8. There is no office telephone number on both websites - official and made-in-China;
9. The factory claimed they have their own export license but could not provide it;

We do not have much confidence in this company mainly because it is small, young and lack of certificates and records in export.
 It is strongly advised to send an auditor and do a factory check.
